Dear Brigid,

On behalf of the producers, cast and crew we would like to extend our gratitude and appreciation for permission to film one of our scenes in the beautiful Town of Millbrook.

Please accept this letter as a formal request to the Township of Cavan Monaghan Council from Netflix/ Fells Point Productions, ULC to consider requesting relief from the Noise By-law and the Filming Guidelines By-law requirement to seek written approval from affected residents to proceed with filming past the 11pm curfew.

Specifically, we would like to propose that the notification process be changed from the current time-honoured format of knocking on resident's doors to garner signatures for approval and be replaced with the current method of the "Have your Say" program which has been adopted by the Cities of Toronto, Mississauga, Hamilton and more recently in the Township of King.

Due to COVID it was deemed problematic to have representatives from film companies to knock on doors and interact directly with residents. People were justifiably reluctant to answer. Instead a very effective system was implemented to letter the areas affected by a filming event and offer the residents the forum to reply by phone or e-mail either to us directly or to the local film office representative to answer questions or raise any concerns. Concerned citizens were called back immediately by us and their questions were answered. If there is no response from the resident, then compliance is accepted.

For the purposes of our proposed upcoming film shoot on Thursday, July 22nd we shall be canvassing the business' on King Street and both myself and Karen Tulk will be available to follow up.

Attached to this request is a first draft of our letter of notification containing the language that explains the process.

Dear Property Owner,

Please be advised that filming in your immediate area will occur on July 22nd with prep on July 20-21 and wrap out on July 23rd.

Production crews will be operating at 24 King Street West, 1 King Street East, 11 Tupper Street and King Street East between Hay Street and Tupper Street during this period. The filming of this production will include:

- A temporary night street closure on King Street between Hay Street and Tupper Street
- Intermittent traffic interruptions on Tupper Street between Bank Street W and King Street East for a driving sequence between 6:00 pm and 9:00 pm
- Parked picture car vehicles on King Street East between Hay Street and Tupper Street
- Parked production and crew vehicles on Centre Street, Millbrook Arena, and on the Millbrook Agricultural Society grounds.
- Temporary alterations to the neighbourhood i.e store and street signage, flags
- Costumed cast and props
- Filming between the approximate hours of 3:00pm and 3:00 am on July 22nd (exemption requested for filming past 11:00 pm)

Fells Point Productions, ULC has been working with the Township of Cavan Monaghan in order to minimize disruption while filming in the community. Please see the Cast & Crew Code of Conduct attached to this letter.

We appreciate your generous support and welcome you to observe filming from a safe distance without compromising the set.

Thank you in advance for your cooperation and understanding.

In response to COVID-19, the Township of Cavan Monaghan has revised the filming approval/objection solicitation process to limit the physical interactions between film crews and residents. If the majority of residents do not object to the requested exemption for late night filming, the film permit will be issued.
