# 6. Report - Finance 2022-01 2nd Draft 2022 Budget Presentation

Kimberley Pope, Director of Finance/Treasurer reviewed for the public the 2<sup>nd</sup> Draft of the 2022 Operating and Capital Budget and budget cuts made by Council during the 1:00 p.m. The Budget Cuts totaled \$85,000 included a reduction of \$25,000 for the MRHAC 2022 Township Incentives from \$50,000; removal of \$10,000 for a transfer to reserves for a Heritage Conservation District Plan (Millbrook); removal of \$20,000 for the Maple Leaf Park Old Shelter Demolition; and the reduction of \$30,000 from the request of \$280,000 transfer to reserves for the 2010 John Deere replacement. Noting in order to maintain the 2.5% Municipal Residential Tax Rate further reductions are required totaling \$26,708.
