11. General Business

11.1 Filming: report provided by Brigid Ayotte regarding road closures and apologized for lateness but advised they the proper paperwork wasn't given until the 14th. Filming for Netflix's Titans will be setting up shortly, Road Closure: June 22 – 25. Tupper, Anne and Hays street will be accessible to the old arena for parking. Huntley asks if in the future, film companies should be included in BIA meetings prior to filming – Ayotte responds that in the past the film company held a meeting with a BIA representative and township, including Emergency services, discussing the filming, however due to the last storm and power outages and pandemic these types of meetings didn't occur. Going forward these meetings will start taking place again.

Garbage removal; will be standard procedure for tenants and businesses. The film crew will be responsible for displacing and replacing the bins to accomodate filming.

LK mentions that Filming personel still haven't finalized their negociations with businesses. Ayotte to forward the street closure contract to Board.

Beach volleyball courts will be open, Lions club will be there with their food truck, DJ and giveaway bikes. Kawartha Downs is going to be doing fireworks on July 2nd. McCulloch will be at KD on July 2nd for their Canada Day event to hand out bags. Brigid will reach out to Kawartha Tourism for information boards that BIA could then adapt for their needs.
- 11.4 Associate Membership: Kennedy brings up that the BIA needs to do a more thorough job at advertising associate members. Kennedy suggests that at the next board meeting we discuss how we can address making associate members more visible on social media and board roles.

He also suggest that we utilize the lions den board to alert everyone coming into the village that there is filming and where to find parking.

Karla from the Library: Library is doing a silent auction and requesting the BIA promote the silent auction on Social Media. They are trying to raise funds so they remain fine free. Mercantile has donated a charcuterie board as a silent auction item.
