# 8.1 Report - Finance 2023-01 2nd Draft Budget Presentation

Kimberley Pope, Director of Finance/Treasurer reviewed the 2nd Draft of the 2023 Operating and Capital Budget and outlined the options for consideration before Council to approve a 5.1% Municipal Residential Tax Rate increase or provide staff direction on the further budget reductions to fund a final budget report for February 21, 2023.
